- To organize various Trainings and orientations for dissemination of messages regarding prevention of HIV/AIDS.

6. To sponsor Rural Athletes from primary to + 3 level & provide studentships, scholarships, fellowships & render other kind of aid to them including books, stipends, awards/ medals & other incentives to establish them as a perfect athlete.
7. To co-operate, co-ordinate & associated with other sports organization, physical training institutions for the benefit of the Rural Athletes.
8. To be affiliated with Govt., District, State & National level Sports organization.
9. To organize & channelize youth energy in character building activities & develop a sense of pride and nationality accepted value like democracy, socialism, secularism, justice, Liberty, Equity, Fraternity, Harmony, Unity, Integrity, Peace & Progress.

10. To raise funds & collect donations, subscriptions for the furtherance of any or all of the objects here in mentioned from the Central & State Govt. Institutions, Corporations, corporate Bodies, nationalized & Cooperative financing agencies, sports Organization & other persons.
11. To empowered collectives of Women & Youths: awareness created & sensible towards their human rights, power for development and social action.
12. To access and attainment of quality education for Children, competency and value based leadership development created among children.
13. To create awareness regarding child protection, child security, child rights, child abuse, foetus etc.

21. To organize and revive Rural based dormant industries for Production of Domestic, Commercial as well as fancy articles through Cottage industries.
22. To infest and invigorate self reliance among the Rural people and building up of a stronger community spirit in the Rural areas.
23. To initiate all necessary steps being relevant towards Promotion of Renewable Energy at all spheres of the Society particularly in Rural area conducting Workshops and massive awareness Campaigns to sensitize the common people for taking the benefits from Renewable Energy and during the daily life of the people instead of other Energy Resources being un-reachable by the Rural Poores in the field of Agriculture, Domestic usage and Commercial Sectors in general.
24. To initiate appropriate steps for Safe Preservation of Old Manuscripts kept in neglected conditions with the different individuals & communities concerning to Literature, History, different Cultures of the People etc. by means of proper Survey and inventories undertaken for restoration of those documents as the National Property.
25. Emphasizing special focus to increase the Productivity of the Rural people in the process of Self-employment and self initiative.
26. To Borrow or avail loans from different financing institutions i.e NABARD/GOVT.OF INDIA/FOREIGN GOVERNMENT agencies or different financing Banks or any other agencies for promotion of developmental activities.
27. To organize and promote Sale Help Groups with linkage and assistance from NABARD.
28. To organize Training & orientations for Artisans engaged in Khadi and Village industries and to insist Co-operative effort among them.
29. To undertake and promote Research in Production Techniques, Applied sciences in Khadi and Village Industries Commission, Govt. of India and Khadi & Village Industry Board, Govt. of Odisha, sector and to provide facilities for Trainings, Orientations and implementation of Small Scale Village Industries/ Rural Schemes for revival/promotion and establishment of various Developmental projects for the Rural Artisans including other category of people in the Society.
30. To initiate and encourage the education and activities of Women on their Rights, liberation, Development, Empowerment, Dignity and Self Sufficiency.
31. To advance and diffuse information's on Educational matters, Formal and Non-formal and with the objectives to subsidies for document ,Print, Publish, issue and circulate, bulletins, papers, Pamphlets, Periodicals, Books, journals, etc. on Education, Development and other related subjects.

32. To conduct and/or participate in seminar, workshops, study circles, camps, field trips, lectures, sports, conferences, statistical /economic/sociological surveys, research and training programmes, audio-visual, and mass services, exhibition, etc. in accordance with in furtherance of the objectives of the Society.
33. To undertake programs/ Network/Campaigns/Workshops for conducting mass awareness Campaigns regarding Safety & security of the Animals, Plants including Environments,
34. To promote & undertake developmental activities for the needy & weaker sections of the Society people to render services for the poorest of the poors & perform activities of charity/relief to those who are in need.
35. To engage in Social Service activities, aiming at improving the living conditions & Socio-Economic standards & general Welfare of the Poverty stricken people , particularly belonging to Tribal's, Adivasis, Scheduled castes, Schedule Tribes, Small, Marginal & landless farmers, agricultural labourers, women & other Backward Communities.
36. To promote Community Health and Services thereof.
37. To Undertake & Assist Agricultural Development & identified programs on irrigation for Sustainable Agriculture.
38. To organize consumer awareness programm and consumer welfare activities for the people.
39. To initiate and assist Village/ Cottage industries, Small Scale Industries, Handicrafts & other programs which provide Self-employment to the Rural poor.
40. To encourage equal opportunities and access to the Community institutions/Government maintained Organizations, Government Offices particularly for Rural Socio-Economic weaker Sections, Scheduled Castes/Scheduled Tribes including women all Category of people residing in the said locality.
41. To insist & Promote Entrepreneurship Development Programme & Multipurpose Food Training programs on Food processing & Cold Storage Units including other Agro. Based industries for preservation of Food Grains, Vegetables, Cereals and other agricultural produces in Rural areas for providing assured and progressive Agro-Farm Unities securing Food Security simultaneously.
42. To undertake watershed programmes for Integrated Development and reverse the process of Degradation of Water, Forest and Soil, adequate off-farm activities for landless ensuring food security. Training do different target groups, promotion of self-help groups, land reclamation, Plantation, water harvesting structures and Fodder Development etc.
43. To eradicate Poverty, illiteracy & leprosy from the Society.
44. To establish Educational Complex, Libraries, recreation centres and organise games, sports etc.
45. To provide Physical, Social & Educational support to the mentality and physically retarded persons of the Society.
46. To provide Social, Moral and ethical supports to the aged, destitute Women and Orphans through establishing and management of Short Stay Homes, Old age Homes, Day care centres etc.
47. To provide better Health for all Rural poor through mobile Health Care services and activities like, Mother & Child Health Care, Immunization programs, Population Control, Sight Saviour activities, Disabled Care Units/Centre's etc.
48. To undertake Social Reform Activities like, removal of superstitions in women folk , Dowry System , Drug De-addiction etc.
49. To conduct Trainings, seminars, workshops, exhibitions and Research programmes etc. as per baseline survey conducted in different project areas emphasizing need based services.
50. To undertake/promote programs/activities relating to the aspect of Science & Technology, Researches, Studies, (modern) Agro. Development, etc. basing on the up-date available information & progressive knowledge and techniques enriching the Individuals/ Institutions./ Organizations/ as a whole.
51. To provide legal Aid Services to the needy and Rural neglected persons particularly destitute, orphans, physical disabled, Street Children, Child Labourers and distressed Women/adolescents etc.
52. To Foster and Build awareness among the people regarding their responsibilities & duties towards the Nation building activities in particular.
53. To upgrade and strengthen the Skills and Capacity of Rural artisans to enable them for introducing Income Generation activities of their own and opportunity for gainfully employment in some sectors or the other.
54. To undertake Social Reform activities for the up- gradation and rehabilitation of Street Children.
55. To receive grants, assistance & loans from Govt. and private agencies operating in India and Abroad.

56. To provide relief to the needy in areas affected by Natural Calamities and other disasters or emergencies.
57. To engage in programmes of Education in general and particularly primary, adult, non-formal education and crèche centres & etc.
58. To promote all manner of cultural activities and dances, dramas, music that will serve to enrich the lives of the people in general and simultaneously revive and sustain the traditional heritage in different Societies/Communities etc.
59. To promote appropriate technology in case of Renewable and Non-conventional sources of energy.
60. To act as a Resource centre for imparting Trainings, conducting Research, Documentation and Consultancy for promotion & Development purposes.
61. To encourage and promote Child Education and Health.
62. To cause and provide medical facility and access for the Common people.
63. To preserve Village Forest and plants of different species so as to maintain Eco-friendly environment. .
64. To expand constructional activities like Dug wells, Bridges, Roads, Ponds, tube wells and Chuas etc.
65. To develop and promote literary personalities among the Rural youth.
66. To set up libraries and study centres in Rural areas.
67. To organize Rural youths for formation of Club, Mahila Samities, Mahila Mandals, Federations, Recreation Centres, and Study centre's, libraries for the purpose of encouraging spirit of National Integrity and collective Unit building secularism, brotherhood and friendly atmosphere in the area of operation of the organization.
68. To build, maintain and running of Guest Houses for the purpose of providing temporary shelters for the Guests, Visitors, Associates, Technical, Professional, Social personnel's with affordable cost and comfortable services.
69. To collaborate/affiliate with voluntary agencies and other agencies and Govt. in developmental activities and relief and rehabilitation programmes.
70. Enter into such contracts or agreements as the Society may think fit for the purposes of the Society and for such or any of these purposes to retain or from time to time, employ and remove skilled, unskilled, professional, technical, administrative, clerical or any other personnel and pay for their services, such as fees, remunerations or such proportion thereof as the Society in its discretion considers expedient.
71. Formation and Organizing Women Groups, Mahila Samitis, Self-Help Groups in the villages of the identified districts, communities for promotion and strengthening of SHGs providing them aids services, linkages in the financing banks, raise funds in shape of Loans from the Government Agency such as Rashtriya Mahila Kosh, Ministry of Women and Child Development, Govt. of India, New Delhi for introduction of Income Generation Programs and to achieve the goal of Women Empowerment.
72. To Borrow any money/funds required for the purposes of the Society upon such terms & upon such securities as may be determined.
73. To invest the money of the Society not immediately required upon such securities or otherwise in such manner as may be determined from time to time.
74. To organize National Integration Programs and various Youth development programs concerning to rational and National thoughts.
75. To organize Skill Development Programs, Capacity Development Trainings, Integrated Design & Technical Development Trainings for the Rural Youths both Men and Women to increase their capacity and strength towards sustainable development and self-employment .
76. To organize awareness programs such as Environment, AIDS Awareness, Health Awareness, Awareness on Safe drinking Water & Sanitation, Drug Addiction, Animal Safety, and other awareness programs concerning to the Society as a whole.
77. To promote and establish men or women Self-Help Groups (S.H.G.s)
78. To take/receive loans from any institution, individual, Govt. or Private agencies in India and abroad.
79. To undertake awareness programs for elimination of child Labour & Women Labour and deliver programs and activities to bring them into main stream of life.
80. To undertake programmes on preservation of Bio-diversity. Ecological balance & Environmental issues.

81. Generally Purchase, take on lease or in exchange, hire or otherwise acquire any Real or personal property or any interest therein, and rights, privileges which the Society may think necessary or convenient with reference to any of the objectives of the Society.
82. To raise funds, undertake & hold such schemes, projects, investments, Industry or any other activity which may generate funds for the Society to implement the objectives of the Society.
83. To draw, make accept, endorse, discount, execute & issue cheques, promissory notes & other negotiable or transferable instruments.
84. To open & operate accounts of any description in any Bank or Banks.
85. To do all such other lawful things as may be incidental or conducive to the attainment of the objectives of the Society.
86. To Promote Research activities in the field of Science, Technology, Environment, Agriculture and other fields of common interest for the greater cause of human being .
87. Promoting Science, Art, Sculpture, Crafts, Rashtrabhasa, Mother tongues and making an effort to create a sense of patriotism and loyalty to the Constitution and the Country.
88. To promote all means of Educational, Social and Economic research and training in the Urban and Rural areas, based on Contemporary Social values and ethics as well as policies of the State and Central Govt., and in accordance with the current and future sectoral needs of the Nation.
89. The Society shall include/emphasis / ensure for promotion of Scientific and Technical & Vocational thoughts/ideas/concepts among the youngsters towards nation building activities.
90. To engage in assessing, formulating programs aiming at human resource development with a specific focus on children, adolescents, youth, women and commercial sections in the Society.
91. To receive donations from any donor for the purpose of development of the cultural and heritage of the Country.
92. To receive Grant-in-Aid/ Loans from the Govt. /Non-govt. agencies/Foreign funding agencies for the purpose of undertaking/implementing any schemes, projects or any other activities providing social aid/assistance or development of SCs/STs or Backward communities of the Society.
93. To work for the advancement of Education, including Academic, Applied Sciences and Vocational areas, through adoption of innovative strategies basing on findings of the Research and Evaluative - Studies conducted by the Society as well as by other bodies including Universities, Autonomous Research and Academic institutions and relevant and reputed Government, Non-government organizations in Odisha and throughout India.
94. To establish and manage Schools/institutions and arranging various programs under the guidance and as per decisions of the Governing Body.
95. To undertake Computer training programs as well as Educational trainings as per syllabus through Computer application in Schools and Colleges as an approved Govt. programs basing on Society's own concept and ideas.
96. To develop amongst youths a sense of Self-respect, self-initiatives and dedication towards the Heritage of Indian Culture, securing traditions and values of life.
97. To take up programs on Rural Development, Agriculture and Animal husbandry, Disaster Mitigation, Health and Sanitation, Rehabilitation of special needy groups, programs of Social defense, Human Rights, Environmental protection and allied programs including human resource and other Natural Resource Management programs including Animal care and Wild life protection.
98. To establish and run Training and Educational institutions, Disaster management units, Renewable Energy units, and Homes for Children, Women and aged, Health Care, Khadi and Village Industries, Co-operatives, Self Help Groups, Marketing linkages & set up of Documentation units and such other centers /units for welfare and integral development of the targeted groups.
99. To undertake study and research projects on social, cultural ideology for the academic needs of society or in connection with Academic and Vocational courses, both independently and in accordance with other Academic and Developmental institutions/organizations/Trusts as shall be deemed essential in pursuance with the objectives of the Society.
100. To open, found, establish, promote, set up, run maintain, assist, finance, support and/or aid or help in the setting up and/ or running study centers, lecture halls and other establishments of institutions for advancement of education and of knowledge in Arts, Science, Literature, humanity , management of all other appropriate subjects/topics along with their manifestations.
101. To promote, advance and encourage and/or aid in helping, promoting, advancing and encouraging primary, Secondary and Higher Education including Managerial, Technical and Medical Education, also physical training of Handicrafts, Fine arts and other useful arts, crafts among the public including the establishment and maintenance of Vocational training centers for them.

102. To promote preservation of Environment and Ecology, promotion of Human and Animal Health, Human intervention towards regeneration of Natural resources.
103. To establish B.Ed., CT, Engineering/Management Institutes/Colleges for Diploma /Degree courses in the various fields of Arts, Science, Commerce and Social Sciences and engineering especially for the weaker sections of the Society for upliftment of poor people and simultaneously for encouraging National integrity in the State of Odisha and India .
104. To organize and implement programs for Rehabilitation and mainstreaming of persons in disadvantages conditions and with disability, and to support their ventures in self employed and entrepreneurship activities through Technical Education and Vocational studies increasing their skill & capacity building towards empowerment.
105. To open, found, establish, promote, set up, run maintain, assist, finance, support and/or aid or help in the setting up and/ or running hospitals, charitable dispensaries, maternity homes, child welfare centers, old age homes/ Nursing Homes, sanatoriums, Hostels and other similar institutions of centers for rendering or providing Medical Relief and/or aid to the suffering humanities or for research centers and institutions for promotion of research and education for medical science including surgery.
106. The Society will create a revolution on the present IT (Information and Technology) world by way of organizing a movement campaign in the realm of human values.
107. The Society will collaborate with NGO's and the sister organizations with relation to its objectives and progressive development of the society as a whole.
108. To provide the Design/Engineering Consultancy/ Management Consultancy, Feasibility studies for various industries, NGO's, S.H.Gs, and Micro Entrepreneurs.
109. To implement programmes on education direct from government, IMF, UGC Sponsor Programmes or other projects to be offered from time to time from various international funding agencies to aiming at to develop awareness on Education, Computer Education, Vocation, Literacy programmes on a time bound agreement.
110. To give proper assistance to Corporate, Government or other Government approved Corporations from time to time by making survey, providing consultancy and market research on their behalf and instruction.
111. To deal with Banking Financial services, legal consultancy as well as services etc.
112. To undertake publication in the field of literature and Socio-Economic Development.
113. To promote low cost shelters with heal their environment for the homeless in the rural and urban areas.
114. To undertake Tourism and Travel activities which includes Tourism Courses like Degree, Diploma etc.
115. To open and patronize Bhagabat Tungis in Rural Areas and encourage the people for revival /restoration of their traditional and ancient heritage and building a indiscriminate healthy Society.
116. To help and provide humanitarian assistances to the religious and charitable institutions in any community under the Banner of Secularism policy guaranteed in the Constitution of India.
117. To run and establish Charitable Organizations/institutions to provide assistances and render Services for the neglected, poor, deserted, destitute people irrespective of class, creed, sex in the Society.
118. To work as a Service Provider agency/Consultant Agency to provide relevant services for the NGOs/ Organizations / Institutions/Trusts/CBOs/ or other deserving groups of the Society by taking reasonable cost/fees. Otherwise being in the frame work of the Constitution of the Society.
119. To undertake e Trainings & Workshops for the Self-Help-Groups with the objectives of Women Empowerment and promotion of Income Generation activities in the Rural as well as urban areas concerned.
120. To formulate/Monitor/implement project/projects involving the NGOs/Trusts on various Aspects of Social activities including training and orientations for preparation of documentations and maintenance of records of the respective organizations for their development and growth purpose.
121. To promote and implement Micro-Credit activities by organizing Women Groups in the Rural as well urban sectors towards strengthening the socio-economic of the needy people and providing up- date information's and knowledge in this regard.
122. To Organize & promote Micro-Insurance in the area of operation of the society by Purchasing franchise from the recognized Govt. Agencies, Non Govt. Agencies or other organizations for wellbeing of the Target beneficiaries and providing a security of life to them.
123. To ensure the enrollment and membership of NGOs,/CBOs/SHGs/Samitis,/ Coop. Societies/ Sanghas, or any other institutions/organizations for the purpose of strengthening the organizational and progressive activities.

This activity not only creates an eco-friendly atmosphere but it intertwines with many hearts together with a fellow feeling to achieve a common goal. During the reporting year of 2017-18, we have Organized Cricket Tournaments, Volley Ball Tournaments, Bad Minton Competitions, Chess & Carom along with Kabadi Games at the Block Head Quarter Nimapada of Puri district to involve the School & College Students, Athletes from different spheres of the district for promotion and creation of a Sports spirit among the inclined youths. The Games & Tournaments are particularly organized i. e Cricket, Volley Ball & Kabadi during January, Chess & Carom in February and Foot Ball from September to November as a regular schedule plan of activities. The Organization seeks participation and encouragements by involving and participation of State level Athletes and sports men to encourage the players and participants.

## AWARENESS ON SWACHHA BHARAT MISSION

The society has been in a scheduled Campaign while organizing “**SWACHHA BHARAT MISSION**” being a part of the Govt. initiatives to save and protect our environment. The Campaign was based on Sanitation arrangements and ensuring cleanliness in the villages, cities, Lanes, Govt. institutions, hospitals, including other Public places involving the common people. In this context, the Society has been organizing the people and conducted awareness Campaigns for cleaning of streets, School campus, and disposal of solid Waste and Waste waters both at Individual and community level. The Campaign has been extended to the district of Puri, Khurda, Bhadrak and Jajpur in Odisha State. The Society involves the School children, Mahila Samities, Youbak Sanghas, Village Development committees to celebrate the Mission and to clean India by 2019. During this year of 2017-18 there are 8 nos of Ralleys by School children, 5 nos of Pada Yatra, and 4 nos of Road Shows have been organized in the district of Puri, Khurda, Bhadrak, Jajpur and Balasore for the purpose of disseminating the message and involvement of the common people, students, and youths for successful achievement of the campaign.

## COMPUTER TRAINING PROGRAMME

The Organization is committed for the Rural youths and un-employed masses for their self-employment through different Vocational Trainings and programs delivered in different project field. It has been revealed with much disgusting that, a large nos of youth are found un-employed and are in search of job. There is no scope of employments or jobs for such people both at private and Government sectors. Because, after development of so many modern techniques in various fields only skilled and technical personnel's get priority in job and employment sectors. Thus, it was decided by the Society to establish Computer Education Centres at various project fields to accommodate such needy groups of the area. Therefore, the organization opened Computer Training Centres in the district of Puri, Khurda and Bhadrak for the purpose of, providing the un-

employed youths an opportunity for self-employment within their periphery locality. The emphasis is given to Schedule Caste, Schedule Tribes, Minorities and other Socio-economic backward communities. The Professional instructors were engaged to conduct regular education according to prescribed syllabus of the Computer Education. A total of 160 beneficiaries i.e 100 male and 60 female candidates from S.C. & S.T. ,Minorities & backwards Communities were imparted with compolte training course during this myear of 2017-18.

## TAILORING, STITCHING & EMBROIDERY

The Society has been greatly concerned for Rural Women, Youths hailed from Scheduled Caste, Scheduled Tribes, Minorities background since they lack opportunity of engagement and providing support for their family. The poverty hunted Rural people are found with helpless and distress affairs since there is no scope for them to find job and employment. . The Society S.P.Foundation is committed towards its Constitution and to provide need based services for the Rural Women particularly in order to increase their existing Skill and capacity towards self employment with their individual efforts. Keeping in eye with the above objectives, the Society decided to open training Centres for Women on Tailoring, Stitching & Embroidery particularly for the rural women in their n respective Localities . In this connection, In this connection, Training Centers are organized in the district of Puri ,Khurda,Bhadrak, Jajpur and Balasore for inclusion of deserving Women for the purpose of providing self-employment . The selection of beneficiaries is done giving preference to the category of SC/ST/OBC along with weaker sections of the respective communities.. During this year of 2017-18 a total of 250 being women beneficiaries were admitted in the training course and completed the scheduled trainings . Professional and Master Trainers were appointed to work as resource persons during the period of 6 month's course. After completion of the training course the candidates were issued with relevant certificates for the purpose.

## COIR TRAINING

The Coir based products has gained popular in Odisha as well in the country and abroad. Coccoanut plant is abundantly available in the coastal belt of Odisha.. The Coir product has already created a favorable and rich marketable platform in India and abroad. Therefore, the marketability status is well established in form of modern techniques and fashionable point view. marketing facilities in different commercial platforms in Odisha and also other parts of the country . Another plus point is that the Coir product has been turned into favorable eye catching fashionable items creating immense base in the foreign countries encouraging the export features . The Women from Self help Groups can best be introduced with the said crafts for self employment and income generation programs. The Raw Material is adequately available for promotion of such activity. Thus, in view of such positive background “S.P.FOUNDATION” the Coir trainings for the SHGs Women beneficiaries particularly facilitatng such Art & Crafts techniques on the aspects of Coir materials:- such as Coir Toys, mats, Ropes, coir decorative materials, Coir Window screens including other domestic articles for the purpose of decreasing unemployment problems creating income generation programs especially at rural point . During this year of 2017-18 there are a total of 320 Women beneficiaries were participated from the above mentioned districts during this year .

## FOOD PROCESSING TRAINING

Agriculture has become the prime and principal occupation of the majority of People in Odisha. The Farmers are not provided with required facilities i.e. Proper Marketing facilities, Storage and processing of Agricultural produces so as to fetch proper returns from their Cropping varieties of produces. In consequence, the poor farmers are put under pressure to make distress sale of food grains facing heavy losses in the cropping pattern. Therefore it is essential to learn the techniques and processes of appropriate storage and processing by the concerned farmers of the respective project fields for possible solution for encouraging farming process. This organization has already conducted several awareness camps to sensitize the people about techniques of food processing and establishment of concerned food Processing Units in their respective villages to aware the people to join in the Food Processing training. During this year a total of 12 nos of Training Camps have been organized in the districts of Puri, Khurda, Bhadrak, Jajpur and Balasore in Odisha State. A total of 540 Beneficiaries ( 340 Women and 200 male ) participated in the workshops organized for the purpose. The theme of the trainings were:- proper grading of variety of Agricultural products, Proper storage and processing of Grains and vegetables for preservation by means of use of certain chemical components for the purpose of securing the food Security for the people in need.

## CONSUMER AWARENESS PROGRAM

The people in general are very often being harassed in terms of quality, quantity, and durability of the goods or commodities purchased from different sources of markets /Hats/ Bazars etc. in this connection, the legal forums constituted by the Government is called as **CONSUMER REDRESSAL FORUMS** both at district , State & National level. The aggrieved consumers of the respective district can redress their grievances in district consumer forums following simple method of applications with little expenses to obtain justice accordingly. In this regard , the organization has been organizing awareness camps in its project areas to sensitize the people for the same. The State Commission of Consumer forum is the appellate court against the decision of the district consumer forums and National Consumer Forum is at Delhi for deciding the appeals from the respective state Forms . Thus, with the objective of sensitizing the people in general , the organization has been conducting regular Awareness Campaigns in the district of Puri ,Khurda,Bhadrak,Jajpur and Balasore . During this year of 2017-18 there were 10 nos of Awareness campaigns organized involving 620 people of the respective districts.

## NATURAL DISASTER PROGRAM

The Odisha has been witnessing terrible and devastating effects of 1 natural calamities such as Super Cyclone, recurring of Floods, Droughts etc. affecting major parts of the State causing heavy damage & loss of valuable lives, , properties, etc. during the past days . A major portion of the population in Odisha comes under below poverty line. The frequent emergence of Natural disasters exhaust the life style of these poor vulnerable people damaging a large volume of valuable Lives and Properties . The poor families are the worst suffers during presence of such Natural disasters and are miserable affected in consequence. The Rural Sector is seriously prone to frequent disasters and the sustenance of life style is becoming more pathetic and tragedy. In this regard, the Society organized villages under its jurisdiction and conducted disaster preparedness trainings in each village. The Village Development Committees were formed in each village in the respective project area and trainings and orientations were done to increase the capacity and knowledge of such inhabitants to face the natural calamities. During this year of 2017-18 a total 12 nos of Camps were organized in the districts of Puri, Khurda, Bhadrak, Jajpur and Balasore. The reputed Resource persons hired from the recognized institutes were participated in the programs. And a total of 430 youths out of which 330 male and 100 are female participated in this programs.

## MOBILE REPAIR

Mobile has become most part and parcel of life style being used by majority of the people irrespective of class, race, Caste and status in the Society. The universal use of Mobile has been an essential instrument by the common people at large. Mobile operation and application has facilitated for Banking, Business, Commercial, Education, Marketing, Service Providers etc. Therefore, the Mobile Repair Training and relevant services techniques is accepted as greatest marketing value in every marketing places, Bazaars, either rural or urban or in remote rural areas. In this connection, it was decided to undertake trainings on repair and services for mobiles in the district of Puri, Khurda, Bhadrak, Jajpur and Balasore for providing self-employment and opportunity for the job seekers. During this year of 2017-18, 340 Youths have completed the training Course working in above districts.

## TRAINING ON HANDICRAFTS

During conduct of Baseline Survey in the project area, it was revealed that, the traditional Artisans working in Rural Areas are leading with a distressed life since their traditional production techniques do not keep pace with this modern society. Their traditional product is being treated as slow moving items and the customers are discouraged after going through the said products. Following the above mentioned negative and persistent affairs of the Rural Artisans, the Society decided to conduct regular Training camps in these areas providing update information about modern technology & process of new strategy of production and simultaneously marketing. There are a total of 8 nos of Training Camp held involving 5 villages such as: 1) Bhattasahi, 2) Thakurpatana, 3) Sahajipatna, 4) Pathardiha, 5) Pachhal, 6) Khadimahara, 7) Ambligaon under Dham Nagar Block jurisdiction in Bhadrak district, Odisha State. Apart from above, the Organization has been working various trainings programs for Stone Carving Artisans working at Bagada, Kushagadia, P.O. Keshanpur, Block-Sora in Balasore district regularly. In this regard, the Society has already organized Self help Groups from traditional Artisan families' and selected deserving Artisans for training purpose. The persons having expertise in the field of Arts & Crafts were engaged for the Workshops/trainings. There are a total of 150 Artisans (100 female and 50 male) from Terracotta at Bhadrak district and 100 Artisans of Stone Carving of Sora Block, Balasore district, Odisha were involved in the training programs.

## DESIGN & TECHNOLOGY DEVELOPMENT WORKSHOP

The Organization has already sought Assistance from the Development Commissioner (Handicrafts), Ministry of Textiles, Govt. of India, New Delhi for providing Training for 30 Artisans working on Stone Carving Crafts of village; Bagada, Kushagadia, P.O. Kesharipur, Soro Block in the district of Balasore since the deserving Artisans belong to the Scheduled Caste Category and they need proper Design & Technology Development Training during this year under report. In this context, the O/o DC(H), Ministry of Textiles, has been kind enough to consider the proposal and extended their kind approval for organizing such Workshop in the above location of the district Balasore during the year 2017-18. The DC(H), New Delhi has made sanction vide their No-I-12012/55/2017-18/DS/CR/SC, Govt. of India, Ministry of Textiles, West Block No-7, R.K. Puram, New Delhi dtd. 01.05.2018. There are 30 Women Artisans from Scheduled Caste are to be involved in the proposed Training. The Training will be conducted for a duration of 2 months and 25 days practical Training at the Venue

stated above. The Empanelled Designers recruited from DC(H), New Delhi, Eastern Zone will be invited for conducting such training. With the direct Supervision and monitoring of Asst. Director, (H), O/o DC(H), M& SEC., Ministry of Textiles Govt. Of India, Bhubaneswar for successful implementation of the training program.

### **AMBEDKAR HASTASLIP VIKAS YOJANA(AHVV)**

The involvement with the Grass Root level prompted this organization to associated with innumerable poor people, women and children, SC, ST, Minority including Rural Artisans who succumb with perennial poverty owing to lack of proper knowledge, Techniques for improvement and enhance of their traditional Craft business. The Handicraft inherited from their fore fathers become primary sustenance of livelihood since they have no other sources of income except selling their labour with low cost. S.P. Foundation while working in the project area could visualize the plights of traditional Terracotta Artisans working at Bhattasahi, Ambhigaon, Kasdimpur, (Mudulisahi), Pachhalo, Anladiha, Gopabandhu Nagar, Thakurpatana, Sahidnagar, under Dham Nagar Block jurisdiction in Bhadrak district, Odisha. During preliminary study report obtained it was revealed that, there are 460 OBC Terracotta Artisans suffer from terrible poverty, because they have no scope to acquire improved knowledge about Design Development, Skill Development, marketing, and other progressive perspective plans responsible for their development and sustenance in the society. The Organization, being sympathized and based on need based service approached the Development commissioner (Handicrafts), Ministry of Textiles, Govt. of India, New Delhi for a mega Project namely "Ambedkar Hastaslip Vikash, Yojana (AHVV) for consideration and approval for sake of these poverty stricken Rural Artisans. The Project is having the large components of designed Programs and activities which will take another 3 years to complete and implementation in the proposed project area concerned. Accordingly, during the year 2017-18, the AHVV Project has been extensively accepted and launched by the sponsoring agency and sanctioned obtained vide their No-C-15011/12/2017-18-CC-(ER)-1, Govt. of India, Ministry of Textiles, O/o the DC(H), (Cluster Section) West Block No-VII, R.K. Puram, New Delhi, dtd. 07.03.2018. and basing on the initial period of 2017-18 Sanction of Rs.1,38,000/- has been received with a released order for Rs.69,000/- being 1st installment of the Project for conducting base Line survey and Organizing 46 Self help Groups of the Artisans reside in the above villages of the cluster. The implementation of Survey and Organizing and mobilizing the Artisans Groups will be conducted accordingly during the period as given by the sponsoring agency.

### **AWARENESS ON RENEWABLE ENERGY**

The people in general are in a habit of exploiting different resources for the purpose of their survival. This includes Electricity, gas, woods, K. Oils etc. in common. But almost the people are ignorant about use and application of Renewable Energy sources instead of traditional energy source. In this connection, the Society is mostly concerned about . Though, there is adequate scope and opportunity for utilizing and applying the Renewable Energy sources in various Livelihood Programs Like: Pottery, Dairy farm, Horticulture, cottage Industries which include : Pottery, Smithy, Carpentry, Textile, Handicrafts ( Bamboo, Metal, ) Embroidery, Leather, handmade paper, production of Building materials, Micro-Enterprise Zone (MEZ), Vegetables, Grains, Fruits, refrigeration, Stitching, mechanical etc. In this context, the society conducted 5 nos of Workshops in the district of Puri, Khurda, Bhadrak, Jajpur and Balasore in Odisha State for sensitizing the people about scope, Technology and application of Renewable Energy to enhance their skill and knowledge for practicing and application of such Renewable energy particularly for Livelihood programs making them sustainable in the process of application and utilization of such resources. There are 430 nos of beneficiaries being 360 from male and 70 from female category participated in the workshops during the year 2017-18.

### **SHG FORMATION & PROMOTION**

The women Empowerment through organizing the women groups in rural area is getting the first priority on the part of the Society since the development is possible by means of participation of women Groups particularly.

Following the Constitution of the Society the founders of the organization are committed to enhance and increasing the traditional life style of Women groups living in abject poverty through their direct involvement in developmental and progressive activities with group spirit. Therefore, it was resolved to organize them in several groups i.e. Self help Groups and impart regular training and orientations towards their capacity development and instill leadership quality. In this regard, the organization has already formed 600 SHGs Groups in in thye district of Puri ,Khurda,Bhadrak, Jajpur and Balasore in Odisha for promotion and strengthening the women groups at rural level and make them self-employed. . These Women groups have already involved in thrift and credit business out of their own savings. The NGO has also been providing regular aid services to the respective SHGs in a systematic manner at regular intervals. They have been duly affiliated with “S.P.FOUNDATION” and are working under the banner of this voluntary organization. The organization has been in a regular effort to open their Savings account in the local financing Banks for promotion and for availing financial facilities from the concerned banks for the purpose of sustainable Development.

### ENVIRONMENT AWARENESS

The Environment has been turned into a crucial chapter at global point considering the safety and security of the Man, Animals, Plants including other bio-diversities on this earth. The Environment degradation has been seriously reflected in various fields such as Global warming, Agriculture, Rainfalls, Water resource, Factories, Productions, Industries and several other Commercial units expeditiously. There is no other ways and means except restoration of Eco-friendly environment for sustenance of this mankind on this earth. In this connection, the Society sought collective initiative of the people by protecting degraded environment with practical delivery of constructive activities towards environment protection . Thus , the organization conducted regular Awareness campaigns in the district of Puri, Khurda, Bhadrak ,jajpur and Balasore. . During this year the Society has organized the School children, Teachers and volunteers of the respective villages and held rallies in different Gram Panchayats to save the environment by means of individual efforts and collective activities . The Students worked as peer educators in this concept. The campaign was made successful through distribution of brochures, fixing big poster and pamphlets in the walls and conspicuous places of the different villages of the concerned district. A total of 10 nos of Campaign organized in the above five districts for the purpose .The beneficiaries involved in this programs are from - Self Help Groups, Mahila Samities, Local NGOs, and CBOs to sensitize the people in general. The participants being 480 i.e Male 380 and 110 female members of the respective communities attended the programs organized by the society during the year 2017-18.

### EDUCATION PROGRAM

The Organization has been working for the weaker sections of the people giving top priority to Schedule Caste, Schedule Tribes, Minority and other vulnerable groups of the Society. In this context, the Society resolved to bring the drop out children for schooling and inclusion of other Child Labourers in the educational stream by means of encouraging them with supply of Educational & Play materials for those non-schooling students who belong to particularly poor & vulnerable groups for Primary Education . The Children are being ensured for schooling by means of providing them the Text Books, Study materials, Toys, and other game instruments for the purpose of restoration of their schooling. In this regard, there were 350 nos of children in the district of Puri and Khurda i provided with Text Books, Slates, pencils, Books, along with Toys and game materials . The scheduled programs were held in the concerned School s and distributed the same with the help of respective

School Teachers, PRI Members and guardians of the concerned villages so as to encourage the parents of the children to take proper interest for schooling of their children's for education.

### **WATER & SANITATION PROGRAM**

The Water & Sanitation is a co-related chapter for a healthy Society. The Water crisis during the coming decades is a matter of great concern. Majority of the people lack practical knowledge about safe drinking water and its use for sake of good health and problem free body. During our base line survey conducted earlier, it was revealed that The Organization in fact has been working at Grass Root level particularly for a long period & basically in rural based areas where large nos of people are deprived of from availing Safe Drinking Water. Majority of them have no knowledge about what is called Safe Drinking Water and from where it can be procured. The necessity of awareness is essentially an effort to save the people from regular infections by using unsafe water and causing a great volume of health hazards and un-necessary expenditures in this regard. It has been experienced that, the people of our project area usually suffer from Water Borne diseases, such as malaria, Fevers, diarrhea, scabies, skin diseases, worm problems and other serious disease like hepatitis, typhoid's, flu's, etc. and the reason is use of unsafe drinking water. Thus, the Society decided to conduct Workshops regarding use of safe Drinking Water in the district of Puri particularly. There were a total of 10 nos of workshops were organized in the district of Puri, Khurda, Bhadrak, Jajpur and Balasore. For the purpose. . A total of 640 beneficiaries i.e. 460 male and 180 female involved in the program. The Workshops conducted by the Resource Persons like Health Experts, Doctors, and professional personnel's to educate and sensitize the people.

### **SKILL DEVELOPMENT PROGRAM**

The Society is seriously concerned about large scale un-employment in Rural Sectors especially. While the modern Society has changed its traditional outlook and diverted its attention towards technical and developed process of living followed with well equipped thoughts and activities thereon. Therefore, in this context trained and skilled capacities of the youths are to be increased following the rapid development and growth of the Society. There is no such proper facility and scopes either in concerned localities or any effort is being delivered to the deserving youths found with wandering in the streets by the Govt. and Non-Govt. agencies to provide required employments for such un-employed idle youths. In this backdrop, it was decided to launch programs like trainings, orientations and Vocational Educations encouraging them for self-employment. Thus, during this year a total of 10 nos of workshops were held in the district of Puri, Khurda, Bhadrak, Jajpur and Balasore to provide opportunity for different Skill development Trainings for such jobless youths of the concerned districts. The selection of candidates was made particularly from Scheduled Castes and Scheduled Tribes Communities including other Socio-economic Backward Communities of the project area. During this year under report a total of 330 youths were successfully participated in the training Camps. Out of total beneficiaries 220 male and female 110 nos. The selected subject matter of themes of the trainings are; - Animal Health Worker, Small Poultry farmers, Pickles making Technicians, Jam jelly ketch up processing, Agarbati Packers, etc. More topics along with prescribed syllabus are proposed to be introduced during the coming years.

### **SUSTAINABLE AGRICULTURE PROGRAM**

According to statistics and population data of Odisha, 80% of the people practically living in rural areas depend on agriculture as their principal livelihood. It has been experienced with much tragedy that frequent floods, droughts and other natural disasters responsible for discouraging the farming to accept and consider the agriculture as their livelihood resource. Because, scanty and irregular rain falls destroy the crops prior to



reaching in harvesting stage . In this regard, there has been a lot of pathetic and grim affairs experienced by the people. Because, many more farmer's death and suicidal episodes are our past records. The matter was seriously taken up by the founder members of the society and it was decided to organize the farmers of different adopted districts and impart technical trainings about sustainable agriculture. During the reporting year of 2016-17 , there were a total of 10 nos of Workshop held in in the district of Puri,Khurda,Bhadrak,Jajpur and Balasore in Odisha State to sensitize the traditional farmer Groups about various processes and techniques of Sustainable Agriculture and innovative procedures of Crops, selection of Seeds, process of low cost cultivation, application and use of indigenous technologies for agricultural purposes. A total of 520 farmers participated in the training camps and received the relevant and latest information about agricultural activities and available technologies for improvement of their productivity capacity. In order to educate the trainees Professional & Technical Personnel's were invited from the district Agriculture Office and professional personnel's from reputed institutions. Agriculture Office, Puri for successful implementation of the programs.

### **SOCIAL FORESTRY & PLANTATION**

“S.P.FOUNDATION” is committed and determined to meet a target for plantation of 25,000 saplings during this year ensuring the common people . The plantation was done in village forests, Community Land including their private lands/orchards. Top priority was also given for the village forests in this regard. The plantation undertaken by the individuals are advised to take care of the saplings till their full growth and survival of the plants during the coming years. The selected plantation done by the different individuals proved to be successful achievement in case of proper care and attention. The plantations include the species of Casurina, Mango, Chakhunda, Eucalypts, Akashi, Gambhari, Tinia etc. Being the local varieties and practically useful for fulfilling the requirements of domestic requirements of wood and fuel woods for the people in large scale and simultaneously protection of degraded environment during the coming days. The plantations done in the district of Puri ,Khurda,Bhadrqak,Jajpur and Balasore. .

### **CULTURAL PROGRAM**

The Organization has been associated deeply having close affinity and rappsots with various communities on the aspect during implementation of several Welfare and developmental activities. The organization seeks the active cooperation and involvement of the concerned communities during the project activities. As a social obligation and being the part and parcel of different communities the Society is witnessing on several Festive occasions and cultural programs organized by the community concerned. Therefore, on the initiatives of the organization the Dramas, folk dances, song competitions, etc. are organized in each year where the large numbers of people including men and women meet together for exchange of ideas, views and entertainment. Our Society avails this opportunity to address the problems, such as drug addiction, deforestation, superstition, illiteracy, abuse of environment etc. in the form of entertainment i.e. drama, folk, dance,odissi dance etc. Involving the local youths for receiving wider public response. In this connection, the Organization facilitates Local Fold dances, odissi dance,Dramas, Sankirtans,

and other Melas, for the purpose togetherness and unity among diversified groups. During this year of report the Society has organized Folk dances, Dramas in the district of Puri for the purpose of heritage preservation and cultural high lights with special focus.

### **VOCATIONAL TRAINING PROGRAM**

The Society has also brought many more development programs particularly for the un-employed youths identified in our various project fields . The management of the society in this regard has been managing and running of vocational training centers in the respective Block Head quarters of the project area. In this connection the society has already opened the Vocational Training Centres at district Head Quarters of Puri,Khurda,Bhadrak,Jajpur and Balasore for the purpose . The beneficiaries are recruited particularly from the Scheduled Castes and Scheduled Tribes Communities and other backwards classes. The selection was made from both the sexes with priority for women candidates in the concerned project area. There are 310 beneficiaries i.e 220 Women and 90 from male category from the above mentioned districts undergone the Vocational Training during the year 2017-18 and successfully completed the Training Courses . Among the trades taken for Vocational subject are: Candle making, Khaliplate & Chaupadi Making, Agarbati making, Badi and Papad making, Carpentry and Masonry etc. to enrich the skill and capacity of rural youths for the purpose of self employment.

### **HEALTH PROGRAM**

The Society found its rich heritage background from a rural landscape and commenced its activities providing need based services particularly for the vulnerable groups which basically cover S.C & S.T, Backward Communities along with other poverty stricken people who have no access to the Health Care facilities as per need of the family . The Organization viewed this subject as primary and essential requirements for such neglected families and decided to provide required services to the deserving masses. Thus, Health Check up Camps were organized in the district of Puri, Khurda, Bhadrak jajpur and Balasore . Majority of populace reside in remote rural sectors are the real beneficiaries in this Campaign. Therefore, the scheduled activities of Health Check Up camps were conducted for the Older People, Women & Children, and Pregnant Women at the respective Block Head Quarters. During this year 2017-18 a total of 12 nos Health check up camps were conducted in the above mentioned area and a total of 520 beneficiaries i.e. female 380 and male 140 received the medical care and attention .The cases being serious and critical were referred to the district Head Quarter's Hospital, Puri for proper care and better medicals services . The Medical officers from local area Hospitals along with professional Health experts invited from various Medical Units attended the Health Check Camps for providing proper treatment. The local Govt. officials, Bank representatives, including PRI members were invited to encourage the participants.

### **NATURAL RESOURCE MANAGEMENT PROGRAM**

Natural Resource being the nature's gift is an important factor for greatest cause of the mankind. The discrimination in use and sharing of those Natural Resource factors cause a great concern and problems for the poor people who are unable to protest it. Where some influential and rich persons of the concerned society apply their force to avail excess than their actual requirement. These things happen due to lack unity amongst the people encourage such forces to make illegal interferences over the available natural resources. Since the day of arrival our NGO activities the matter has been settled. It was decided to initiate proper measures for equal access to the available natural Resources by each individuals, group of individuals, any class, creed and social status of the people reside in the Society. Generally, the natural resources consist of , Pasture land, Natural Rivers, Mountains, village ponds, etc. Our organization has already formed 650 Village Development Committees in the district of Puri, Khurda,Bhadrak, Jajpur and Balasore for judicious use & management of Natural Resources without any discrimination. The Committees hold meetings at regular intervals and discuss about the problems and difficulties faced by the people, groups, community concerned and to set aside the matter

on convergent. The said committee is represented by the Sarapanch, Zilla Parishad members of the respective Panchayats for strengthening the action plan and activities scheduled for the purpose. The NGO Coordinators are working in each village to guide and counsel the committees as a regular routine work.

## OBSERVATION AND CELEBRATION

“S.P.FOUNDATION” has been working in the Social Sectors for a long span. There are multi- concept Social chapters of diverse unit of the Society being related to the daily life of the numerous beneficiaries prompts essentially to memorize the each events / topic concerning to any subject touching the Constitution of the society is honoured equally in the manner the event/topic deserves likewise in the society/class of people/ Category of people/community as has been prioritized as National and State Events.
